Discussed Mount Hope Road. The county plans on paving Mount Hope from Carson City to Fenwick Road later this year. Depending on cost, discussed paying for paving of Mount Hope from Fenwick to Daily as a loan to the county to have the entire road completed this year. **Motion** by Ryan, seconded by Schneider to approach Montcalm County Road Commission with possibility of paving all of Mount Hope Road this year, with the township paying for the stretch between Fenwick and Daily roads as a loan to the county. Carried.
